How does Amazon process your data

Alexa does not record all conversations by default. The Echo device is designed to detect only the wake word "Alexa". No audio is stored or sent to the cloud unless the device detects the wake word "Alexa" or pressing the wake button.

Voice recording is set to "Don't save recordings."

Echo dot devices used for Voice Activated Smart Classroom are configured not to save any recordings after the wake word is invoked. The recording function of all of the Voice Activated Smart Classroom Devices managed by the Information Technology Department of UW Tacoma are permanently turned off. No recordings/data will be saved and/or transmitted to the cloud storage made available for these devices.

- 3. Catalyst Tools

Seattle will retire two Catalyst tools WebQ and Catalyst GradeBook on **June 16, 2022**. Canvas Grade Book is to replace Catalyst GradeBook. For WebQ users, our recommendation is to use Qualtrics (i.e. UW Tacoma has campus license), Microsoft Form or Google Form. Users can download any needed data (e.g., survey content and responses or past gradebooks) from the respective Catalyst tool now. After retirement, content will be available to download from a new self-service archive through **July 31, 2024**.

- 5. UW Google
 - Google announced significant changes to their education offering, discontinuing "G Suite for Education" and replacing it with "<u>Google Workspace for Education</u>". Alongside this name change came additional changes to technology, policy, and licensing. Notably, Google announced that their <u>Google Workspace for Education Fundamentals</u> offering would no longer offer unlimited storage and would instead offer a *significantly reduced level of storage*. Google also announced that the use of shared and business accounts (aka <u>Shared UW NetIDs</u>) with Google Workspace for Education was prohibited.
 - Impact: No shared UW NetIDs allowed with UW Google. Notification and communication starts in March 2022. All shared NetIDs will be removed September 2023.
 - End of "Unlimited" Storage Space: each user will be offered 100GB quotas. (1,720 current UW accounts are over 100GB). Working on documentation for user managed migrations and services. Also working with Microsoft and AvaPoint to determine if UW can offer migration services to UW Office 365.

6. UW Microsoft Office 365

UW has entered into a new <u>Microsoft Office 365</u> contract until June 2025. The new contract includes:

- Microsoft 365 A5 for Faculty (available to faculty, emeritus faculty, staff or accounts licensed by departments upgrade to Microsoft 365 A5 for Faculty (but will not include faculty with unpaid academic appointments, student workers or affiliated employees other than emeritus faculty)
- Departments will be able to purchase a pool of **Microsoft 365 A5 for Faculty** that they can apply to other accounts at \$110 per Microsoft contract year.
- User facing enhancements include PowerBI (Pro), dial-in for Teams meetings organized/ created by account; minor improvements to To-Do, Forms, Whiteboard, and Stream.
- *Microsoft 365 A5 student use benefits* will increase overall service for UW students. However, it includes only a subset of **Microsoft 365 A5 for Faculty**, preserving most features of the existing student licensing and Power BI (Pro) access.
- Potential Impacts to UW users:
 - Shared NetIDs and personal NetID receiving services via Provisioning Request Tool will be downgraded.
 - Mailbox reduced to 50GB from 100GB
 - OneDrive for Business reduced to 1TB from 5 TB
 - No Teams Dataverse and Virtual Agents
 - No Bookings
 - No ability to send Microsoft 365 encrypted email
